



BEARFACTS 1993 – 2003

Wheatland , Montana [30107]

Wheatland is one of 56 counties in Montana. It is not part of a Metropolitan Area. Its 2003 population of 2,102 ranked 44th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Wheatland had a per capita personal income (PCPI) of \$18,931. This PCPI ranked 54th in the state and was 72 percent of the state average, \$26,373, and 60 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 13.3 percent from 2002. The 2002-2003 state change was 5.2 percent and the national change was 2.2 percent. In 1993 the PCPI of Wheatland was \$16,702 and ranked 33rd in the state. The 1993-2003 average annual growth rate of PCPI was 1.3 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Wheatland had a total personal income (TPI) of \$39,794*. This TPI ranked 48th in the state and accounted for 0.2 percent of the state total. In 1993 the TPI of Wheatland was \$38,282* and ranked 46th in the state. The 2003 TPI reflected an increase of 9.5 percent from 2002. The 2002-2003 state change was 6.0 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 0.4 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Wheatland. In 2003 net earnings accounted for 41.9 percent of TPI (compared with 52.7 in 1993); dividends, interest, and rent were 29.1 percent (compared with 25.8 in 1993); and personal current transfer receipts were 28.9 percent (compared with 21.4 in 1993). From 2002 to 2003 net earnings increased 20.4 percent; dividends, interest, and rent increased 3.5 percent; and personal current transfer receipts increased 1.9 percent. From 1993 to 2003 net earnings decreased on average 1.9 percent each year; dividends, interest, and rent increased on average 1.6 percent; and personal current transfer receipts increased on average 3.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Wheatland increased from \$14,905* in 2002 to \$17,855* in 2003, an increase of 19.8 percent. The 2002-2003 state change was 6.2 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$21,879* to the 2003 estimate was - 2.0 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.3 percent.
