



BEARFACTS 1993 – 2003

Fort Bend , Texas [48157]

Fort Bend is one of 254 counties in Texas. It is part of the [Houston-Sugar Land-Baytown, TX \(MSA\)](#). Its 2003 population of 416,407 ranked 10th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Fort Bend had a per capita personal income (PCPI) of \$33,450. This PCPI ranked 13th in the state and was 114 percent of the state average, \$29,436, and 106 percent of the national average, \$31,530. The 2003 PCPI reflected a decrease of 0.5 percent from 2002. The 2002-2003 state change was 2.0 percent and the national change was 2.2 percent. In 1993 the PCPI of Fort Bend was \$22,466 and ranked 19th in the state. The 1993-2003 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Fort Bend had a total personal income (TPI) of \$13,928,713*. This TPI ranked 9th in the state and accounted for 2.1 percent of the state total. In 1993 the TPI of Fort Bend was \$5,952,142* and ranked 9th in the state. The 2003 TPI reflected an increase of 4.4 percent from 2002. The 2002-2003 state change was 3.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 8.9 percent. The average annual growth rate for the state was 6.2 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Fort Bend. In 2003 net earnings accounted for 82.3 percent of TPI (compared with 82.4 in 1993); dividends, interest, and rent were 11.4 percent (compared with 12.1 in 1993); and personal current transfer receipts were 6.3 percent (compared with 5.5 in 1993). From 2002 to 2003 net earnings increased 3.5 percent; dividends, interest, and rent increased 7.2 percent; and personal current transfer receipts increased 11.6 percent. From 1993 to 2003 net earnings increased on average 8.9 percent each year; dividends, interest, and rent increased on average 8.2 percent; and personal current transfer receipts increased on average 10.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Fort Bend increased from \$5,589,722* in 2002 to \$5,912,893* in 2003, an increase of 5.8 percent. The 2002-2003 state change was 3.5 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$2,349,768* to the 2003 estimate was 9.7 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.3 percent.
