



BEARFACTS 1993 – 2003

Hartley , Texas [48205]

Hartley is one of 254 counties in Texas. It is not part of a Metropolitan Area. Its 2003 population of 5,400 ranked 198th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Hartley had a per capita personal income (PCPI) of \$31,990. This PCPI ranked 16th in the state and was 109 percent of the state average, \$29,436, and 101 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 6.8 percent from 2002. The 2002-2003 state change was 2.0 percent and the national change was 2.2 percent. In 1993 the PCPI of Hartley was \$33,816 and ranked 2nd in the state. The 1993-2003 average annual growth rate of PCPI was - 0.6 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Hartley had a total personal income (TPI) of \$172,748*. This TPI ranked 184th in the state and accounted for 0.0 percent of the state total. In 1993 the TPI of Hartley was \$127,958* and ranked 178th in the state. The 2003 TPI reflected an increase of 13.2 percent from 2002. The 2002-2003 state change was 3.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 3.0 percent. The average annual growth rate for the state was 6.2 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hartley. In 2003 net earnings accounted for 83.0 percent of TPI (compared with 83.8 in 1993); dividends, interest, and rent were 11.3 percent (compared with 11.8 in 1993); and personal current transfer receipts were 5.7 percent (compared with 4.4 in 1993). From 2002 to 2003 net earnings increased 17.5 percent; dividends, interest, and rent decreased 8.6 percent; and personal current transfer receipts increased 5.7 percent. From 1993 to 2003 net earnings increased on average 3.0 percent each year; dividends, interest, and rent increased on average 2.6 percent; and personal current transfer receipts increased on average 5.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hartley increased from \$91,277* in 2002 to \$110,378* in 2003, an increase of 20.9 percent. The 2002-2003 state change was 3.5 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$88,705* to the 2003 estimate was 2.2 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.3 percent.
