



BEARFACTS 1994 – 2004

Boise City-Nampa (MSA) [14260]

Boise City-Nampa is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2004 population of 523,597 ranked 88th in the nation.

PER CAPITA PERSONAL INCOME

In 2004 Boise City-Nampa had a per capita personal income (PCPI) of \$31,293. This PCPI ranked 125th in the United States and was 94 percent of the national average, \$33,157. The 2004 PCPI reflected an increase of 7.2 percent from 2003. The 2003-2004 national change was 5.2 percent. In 1994 the PCPI of Boise City-Nampa was \$22,163 and ranked 90th in the United States. The 1994-2004 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Boise City-Nampa had a total personal income (TPI) of \$16,385,028*. This TPI ranked 89th in the United States. In 1994 the TPI of Boise City-Nampa was \$8,425,588* and ranked 103rd in the United States. The 2004 TPI reflected an increase of 9.9 percent from 2003. The 2003-2004 national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 6.9 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Boise City-Nampa. In 2004 net earnings accounted for 69.9 percent of TPI (compared with 72.0 in 1994); dividends, interest, and rent were 18.5 percent (compared with 17.7 in 1994); and personal current transfer receipts were 11.5 percent (compared with 10.3 in 1994). From 2003 to 2004 net earnings increased 9.1 percent; dividends, interest, and rent increased 15.3 percent; and personal current transfer receipts increased 6.6 percent. From 1994 to 2004 net earnings increased on average 6.6 percent each year; dividends, interest, and rent increased on average 7.4 percent; and personal current transfer receipts increased on average 8.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Boise City-Nampa increased from \$11,787,035* in 2003 to \$12,835,784* in 2004, an increase of 8.9 percent. The 2003-2004 national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$6,871,083* to the 2004 estimate was 6.4 percent. The average annual growth rate for the nation was 5.5 percent.
