



BEARFACTS 1994 – 2004

Bonner , Idaho [16017]

Bonner is one of 44 counties in Idaho. It is not part of a Metropolitan Area. Its 2004 population of 39,121 ranked 8th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Bonner had a per capita personal income (PCPI) of \$23,873. This PCPI ranked 21st in the state and was 87 percent of the state average, \$27,361, and 72 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 9.3 percent from 2003. The 2003-2004 state change was 7.2 percent and the national change was 5.1 percent. In 1994 the PCPI of Bonner was \$16,044 and ranked 21st in the state. The 1994-2004 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Bonner had a total personal income (TPI) of \$933,944*. This TPI ranked 9th in the state and accounted for 2.5 percent of the state total. In 1994 the TPI of Bonner was \$513,018* and ranked 10th in the state. The 2004 TPI reflected an increase of 10.8 percent from 2003. The 2003-2004 state change was 9.4 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 6.2 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bonner. In 2004 net earnings accounted for 57.4 percent of TPI (compared with 59.5 in 1994); dividends, interest, and rent were 23.7 percent (compared with 23.7 in 1994); and personal current transfer receipts were 18.9 percent (compared with 16.8 in 1994). From 2003 to 2004 net earnings increased 10.6 percent; dividends, interest, and rent increased 15.6 percent; and personal current transfer receipts increased 5.8 percent. From 1994 to 2004 net earnings increased on average 5.8 percent each year; dividends, interest, and rent increased on average 6.2 percent; and personal current transfer receipts increased on average 7.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Bonner increased from \$503,249* in 2003 to \$558,318* in 2004, an increase of 10.9 percent. The 2003-2004 state change was 8.7 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$325,381* to the 2004 estimate was 5.5 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.5 percent.
