



BEARFACTS 1994 – 2004

Trigg , Kentucky [21221]

Trigg is one of 120 counties in Kentucky. It is part of the [Clarksville, TN-KY \(MSA\)](#). Its 2004 population of 13,038 ranked 87th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Trigg had a per capita personal income (PCPI) of \$28,649. This PCPI ranked 15th in the state and was 106 percent of the state average, \$27,017, and 86 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 6.3 percent from 2003. The 2003-2004 state change was 4.5 percent and the national change was 5.1 percent. In 1994 the PCPI of Trigg was \$16,538 and ranked 47th in the state. The 1994-2004 average annual growth rate of PCPI was 5.6 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Trigg had a total personal income (TPI) of \$373,530*. This TPI ranked 66th in the state and accounted for 0.3 percent of the state total. In 1994 the TPI of Trigg was \$183,454* and ranked 78th in the state. The 2004 TPI reflected an increase of 8.8 percent from 2003. The 2003-2004 state change was 5.2 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 7.4 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Trigg. In 2004 net earnings accounted for 67.9 percent of TPI (compared with 61.4 in 1994); dividends, interest, and rent were 12.4 percent (compared with 17.7 in 1994); and personal current transfer receipts were 19.7 percent (compared with 20.9 in 1994). From 2003 to 2004 net earnings increased 10.4 percent; dividends, interest, and rent increased 3.4 percent; and personal current transfer receipts increased 6.9 percent. From 1994 to 2004 net earnings increased on average 8.5 percent each year; dividends, interest, and rent increased on average 3.6 percent; and personal current transfer receipts increased on average 6.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Trigg increased from \$147,465* in 2003 to \$176,204* in 2004, an increase of 19.5 percent. The 2003-2004 state change was 5.7 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$96,457* to the 2004 estimate was 6.2 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.5 percent.
