



BEARFACTS 1994 – 2004

Burke , North Carolina [37023]

Burke is one of 100 counties in North Carolina. It is part of the [Hickory-Lenoir-Morganton, NC \(MSA\)](#). Its 2004 population of 88,658 ranked 30th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Burke had a per capita personal income (PCPI) of \$24,736. This PCPI ranked 53rd in the state and was 84 percent of the state average, \$29,440, and 75 percent of the national average, \$33,157. The 2004 PCPI reflected an increase of 3.1 percent from 2003. The 2003-2004 state change was 5.4 percent and the national change was 5.2 percent. In 1994 the PCPI of Burke was \$18,224 and ranked 41st in the state. The 1994-2004 average annual growth rate of PCPI was 3.1 percent. The average annual growth rate for the state was 3.7 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Burke had a total personal income (TPI) of \$2,193,006*. This TPI ranked 32nd in the state and accounted for 0.9 percent of the state total. In 1994 the TPI of Burke was \$1,486,877* and ranked 30th in the state. The 2004 TPI reflected an increase of 2.9 percent from 2003. The 2003-2004 state change was 6.8 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 4.0 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Burke. In 2004 net earnings accounted for 65.6 percent of TPI (compared with 68.9 in 1994); dividends, interest, and rent were 13.6 percent (compared with 16.0 in 1994); and personal current transfer receipts were 20.8 percent (compared with 15.2 in 1994). From 2003 to 2004 net earnings increased 3.2 percent; dividends, interest, and rent decreased 2.5 percent; and personal current transfer receipts increased 5.4 percent. From 1994 to 2004 net earnings increased on average 3.5 percent each year; dividends, interest, and rent increased on average 2.3 percent; and personal current transfer receipts increased on average 7.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Burke increased from \$1,426,693* in 2003 to \$1,480,754* in 2004, an increase of 3.8 percent. The 2003-2004 state change was 6.1 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$1,089,636* to the 2004 estimate was 3.1 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.5 percent.
