



BEARFACTS 1994 – 2004

Oliver , North Dakota [38065]

Oliver is one of 53 counties in North Dakota. It is not part of a Metropolitan Area. Its 2004 population of 1,834 ranked 49th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Oliver had a per capita personal income (PCPI) of \$29,973. This PCPI ranked 8th in the state and was 102 percent of the state average, \$29,279, and 90 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 13.6 percent from 2003. The 2003-2004 state change was 2.0 percent and the national change was 5.1 percent. In 1994 the PCPI of Oliver was \$15,892 and ranked 43rd in the state. The 1994-2004 average annual growth rate of PCPI was 6.6 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Oliver had a total personal income (TPI) of \$54,971*. This TPI ranked 47th in the state and accounted for 0.3 percent of the state total. In 1994 the TPI of Oliver was \$34,597* and ranked 49th in the state. The 2004 TPI reflected an increase of 11.1 percent from 2003. The 2003-2004 state change was 2.6 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 4.7 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Oliver. In 2004 net earnings accounted for 71.9 percent of TPI (compared with 69.2 in 1994); dividends, interest, and rent were 14.8 percent (compared with 17.6 in 1994); and personal current transfer receipts were 13.3 percent (compared with 13.2 in 1994). From 2003 to 2004 net earnings increased 17.6 percent; dividends, interest, and rent decreased 9.6 percent; and personal current transfer receipts increased 6.2 percent. From 1994 to 2004 net earnings increased on average 5.1 percent each year; dividends, interest, and rent increased on average 3.0 percent; and personal current transfer receipts increased on average 4.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Oliver increased from \$41,563* in 2003 to \$48,354* in 2004, an increase of 16.3 percent. The 2003-2004 state change was 2.9 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$30,700* to the 2004 estimate was 4.6 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.5 percent.
