



BEARFACTS 1994 – 2004

Sheridan , Wyoming [56033]

Sheridan is one of 23 counties in Wyoming. It is part of the Sheridan, WY Micropolitan SA. Its 2004 population of 27,012 ranked 7th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Sheridan had a per capita personal income (PCPI) of \$38,012. This PCPI ranked 4th in the state and was 108 percent of the state average, \$35,283, and 115 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 10.5 percent from 2003. The 2003-2004 state change was 7.3 percent and the national change was 5.1 percent. In 1994 the PCPI of Sheridan was \$21,917 and ranked 3rd in the state. The 1994-2004 average annual growth rate of PCPI was 5.7 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Sheridan had a total personal income (TPI) of \$1,026,783*. This TPI ranked 6th in the state and accounted for 5.8 percent of the state total. In 1994 the TPI of Sheridan was \$553,528* and ranked 7th in the state. The 2004 TPI reflected an increase of 10.6 percent from 2003. The 2003-2004 state change was 8.1 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 6.4 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Sheridan. In 2004 net earnings accounted for 52.4 percent of TPI (compared with 55.9 in 1994); dividends, interest, and rent were 34.7 percent (compared with 29.6 in 1994); and personal current transfer receipts were 12.8 percent (compared with 14.5 in 1994). From 2003 to 2004 net earnings increased 9.5 percent; dividends, interest, and rent increased 14.7 percent; and personal current transfer receipts increased 4.9 percent. From 1994 to 2004 net earnings increased on average 5.7 percent each year; dividends, interest, and rent increased on average 8.1 percent; and personal current transfer receipts increased on average 5.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Sheridan increased from \$510,162* in 2003 to \$561,055* in 2004, an increase of 10.0 percent. The 2003-2004 state change was 8.4 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$321,627* to the 2004 estimate was 5.7 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.5 percent.
