



BEARFACTS 1995 – 2005 Jackson , Louisiana [22049]

Jackson is one of 64 counties in Louisiana. It is part of the Ruston, LA Micropolitan SA. Its 2005 population of 15,058 ranked 52nd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Jackson had a per capita personal income (PCPI) of \$23,678. This PCPI ranked 31st in the state and was 96 percent of the state average, \$24,651, and 68 percent of the national average, \$34,690. The 2005 PCPI reflected a decrease of 2.3 percent from 2004. The 2004-2005 state change was -9.6 percent and the national change was 4.6 percent. In 1995 the PCPI of Jackson was \$17,587 and ranked 16th in the state. The 1995-2005 average annual growth rate of PCPI was 3.0 percent. The average annual growth rate for the state was 2.6 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Jackson had a total personal income (TPI) of \$356,550*. This TPI ranked 49th in the state and accounted for 0.3 percent of the state total. In 1995 the TPI of Jackson was \$272,265* and ranked 49th in the state. The 2005 TPI reflected a decrease of 2.9 percent from 2004. The 2004-2005 state change was - 9.4 percent and the national change was 5.6 percent. The 1995-2005 average annual growth rate of TPI was 2.7 percent. The average annual growth rate for the state was 2.9 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Jackson. In 2005 net earnings accounted for 61.4 percent of TPI (compared with 58.3 in 1995); dividends, interest, and rent were 7.9 percent (compared with 15.1 in 1995); and personal current transfer receipts were 30.8 percent (compared with 26.6 in 1995). From 2004 to 2005 net earnings increased 3.1 percent; dividends, interest, and rent decreased 43.6 percent; and personal current transfer receipts increased 4.3 percent. From 1995 to 2005 net earnings increased on average 3.3 percent each year; dividends, interest, and rent decreased on average 3.7 percent; and personal current transfer receipts increased on average 4.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Jackson increased from \$180,339* in 2004 to \$186,408* in 2005, an increase of 3.4 percent. The 2004-2005 state change was - 1.8 percent and the national change was 5.3 percent. The average annual growth rate from the 1995 estimate of \$143,259* to the 2005 estimate was 2.7 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 5.5 percent.
