



BEARFACTS 1995 – 2005

Panama City-Lynn Haven-Panama City Beach (MSA) [37460]

Panama City-Lynn Haven-Panama City Beach is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2005 population of 161,458 ranked 236th in the nation.

PER CAPITA PERSONAL INCOME

In 2005 Panama City-Lynn Haven-Panama City Beach had a per capita personal income (PCPI) of \$30,473. This PCPI ranked 169th in the United States and was 88 percent of the national average, \$34,690. The 2005 PCPI reflected an increase of 6.3 percent from 2004. The 2004-2005 national change was 4.6 percent. In 1995 the PCPI of Panama City-Lynn Haven-Panama City Beach was \$18,430 and ranked 293rd in the United States. The 1995-2005 average annual growth rate of PCPI was 5.2 percent. The average annual growth rate for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Panama City-Lynn Haven-Panama City Beach had a total personal income (TPI) of \$4,920,141*. This TPI ranked 223rd in the United States. In 1995 the TPI of Panama City-Lynn Haven-Panama City Beach was \$2,618,902* and ranked 259th in the United States. The 2005 TPI reflected an increase of 8.8 percent from 2004. The 2004-2005 national change was 5.6 percent. The 1995-2005 average annual growth rate of TPI was 6.5 percent. The average annual growth rate for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Panama City-Lynn Haven-Panama City Beach. In 2005 net earnings accounted for 63.9 percent of TPI (compared with 66.1 in 1995); dividends, interest, and rent were 17.7 percent (compared with 16.2 in 1995); and personal current transfer receipts were 18.4 percent (compared with 17.7 in 1995). From 2004 to 2005 net earnings increased 10.0 percent; dividends, interest, and rent increased 8.1 percent; and personal current transfer receipts increased 5.4 percent. From 1995 to 2005 net earnings increased on average 6.1 percent each year; dividends, interest, and rent increased on average 7.5 percent; and personal current transfer receipts increased on average 6.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Panama City-Lynn Haven-Panama City Beach increased from \$3,308,572* in 2004 to \$3,644,970* in 2005, an increase of 10.2 percent. The 2004-2005 national change was 5.3 percent. The average annual growth rate from the 1995 estimate of \$1,979,911* to the 2005 estimate was 6.3 percent. The average annual growth rate for the nation was 5.5 percent.
