



BEARFACTS 1995 – 2005

Sebastian-Vero Beach (MSA) [42680]

Sebastian-Vero Beach is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2005 population of 126,578 ranked 288th in the nation.

PER CAPITA PERSONAL INCOME

In 2005 Sebastian-Vero Beach had a per capita personal income (PCPI) of \$49,930. This PCPI ranked 5th in the United States and was 144 percent of the national average, \$34,690. The 2005 PCPI reflected an increase of 5.4 percent from 2004. The 2004-2005 national change was 4.6 percent. In 1995 the PCPI of Sebastian-Vero Beach was \$29,844 and ranked 8th in the United States. The 1995-2005 average annual growth rate of PCPI was 5.3 percent. The average annual growth rate for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Sebastian-Vero Beach had a total personal income (TPI) of \$6,320,096*. This TPI ranked 193rd in the United States. In 1995 the TPI of Sebastian-Vero Beach was \$3,041,925* and ranked 227th in the United States. The 2005 TPI reflected an increase of 7.7 percent from 2004. The 2004-2005 national change was 5.6 percent. The 1995-2005 average annual growth rate of TPI was 7.6 percent. The average annual growth rate for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Sebastian-Vero Beach. In 2005 net earnings accounted for 33.3 percent of TPI (compared with 35.1 in 1995); dividends, interest, and rent were 53.1 percent (compared with 48.7 in 1995); and personal current transfer receipts were 13.6 percent (compared with 16.2 in 1995). From 2004 to 2005 net earnings increased 9.6 percent; dividends, interest, and rent increased 13.7 percent; and personal current transfer receipts decreased 13.9 percent. From 1995 to 2005 net earnings increased on average 7.0 percent each year; dividends, interest, and rent increased on average 8.5 percent; and personal current transfer receipts increased on average 5.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Sebastian-Vero Beach increased from \$2,161,261* in 2004 to \$2,359,306* in 2005, an increase of 9.2 percent. The 2004-2005 national change was 5.3 percent. The average annual growth rate from the 1995 estimate of \$1,209,174* to the 2005 estimate was 6.9 percent. The average annual growth rate for the nation was 5.5 percent.
