



BEARFACTS 1995 – 2005

Rutherford , Tennessee [47149]

Rutherford is one of 95 counties in Tennessee. It is part of the [Nashville-Davidson-Murfreesboro-Franklin, TN \(MSA\)](#). Its 2005 population of 219,839 ranked 5th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Rutherford had a per capita personal income (PCPI) of \$29,565. This PCPI ranked 13th in the state and was 96 percent of the state average, \$30,827, and 85 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 3.9 percent from 2004. The 2004-2005 state change was 4.4 percent and the national change was 4.9 percent. In 1995 the PCPI of Rutherford was \$21,915 and ranked 8th in the state. The 1995-2005 average annual growth rate of PCPI was 3.0 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Rutherford had a total personal income (TPI) of \$6,499,560*. This TPI ranked 6th in the state and accounted for 3.5 percent of the state total. In 1995 the TPI of Rutherford was \$3,301,781* and ranked 6th in the state. The 2005 TPI reflected an increase of 8.4 percent from 2004. The 2004-2005 state change was 5.7 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 7.0 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Rutherford. In 2005 net earnings accounted for 79.6 percent of TPI (compared with 78.9 in 1995); dividends, interest, and rent were 9.0 percent (compared with 11.7 in 1995); and personal current transfer receipts were 11.4 percent (compared with 9.4 in 1995). From 2004 to 2005 net earnings increased 7.8 percent; dividends, interest, and rent increased 11.0 percent; and personal current transfer receipts increased 10.9 percent. From 1995 to 2005 net earnings increased on average 7.1 percent each year; dividends, interest, and rent increased on average 4.2 percent; and personal current transfer receipts increased on average 9.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Rutherford increased from \$5,051,443* in 2004 to \$5,379,936* in 2005, an increase of 6.5 percent. The 2004-2005 state change was 5.2 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$2,829,568* to the 2005 estimate was 6.6 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.5 percent.
