



BEARFACTS 1995 – 2005

Bath , Virginia [51017]

Bath is one of 105 counties in Virginia. It is not part of a Metropolitan Area. Its 2005 population of 4,792 ranked 104th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Bath had a per capita personal income (PCPI) of \$31,343. This PCPI ranked 36th in the state and was 83 percent of the state average, \$37,968, and 90 percent of the national average, \$34,757. The 2005 PCPI reflected a decrease of 1.3 percent from 2004. The 2004-2005 state change was 5.9 percent and the national change was 4.9 percent. In 1995 the PCPI of Bath was \$20,474 and ranked 32nd in the state. The 1995-2005 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Bath had a total personal income (TPI) of \$150,194*. This TPI ranked 103rd in the state and accounted for 0.1 percent of the state total. In 1995 the TPI of Bath was \$101,427* and ranked 102nd in the state. The 2005 TPI reflected a decrease of 2.8 percent from 2004. The 2004-2005 state change was 7.3 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 4.0 percent. The average annual growth rate for the state was 6.0 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bath. In 2005 net earnings accounted for 55.8 percent of TPI (compared with 58.4 in 1995); dividends, interest, and rent were 24.2 percent (compared with 23.7 in 1995); and personal current transfer receipts were 20.0 percent (compared with 17.9 in 1995). From 2004 to 2005 net earnings increased 2.6 percent; dividends, interest, and rent decreased 19.2 percent; and personal current transfer receipts increased 7.7 percent. From 1995 to 2005 net earnings increased on average 3.5 percent each year; dividends, interest, and rent increased on average 4.2 percent; and personal current transfer receipts increased on average 5.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Bath increased from \$91,512* in 2004 to \$92,864* in 2005, an increase of 1.5 percent. The 2004-2005 state change was 7.0 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$70,335* to the 2005 estimate was 2.8 percent. The average annual growth rate for the state was 6.6 percent and for the nation was 5.5 percent.
