



BEARFACTS 1996 – 2006

Shelby , Iowa [19165]

Shelby is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2006 population of 12,305 ranked 61st in the state.

PER CAPITA PERSONAL INCOME

In 2006 Shelby had a per capita personal income (PCPI) of \$30,571. This PCPI ranked 38th in the state and was 93 percent of the state average, \$32,741, and 83 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 2.2 percent from 2005. The 2005-2006 state change was 3.7 percent and the national change was 6.1 percent. In 1996 the PCPI of Shelby was \$21,564 and ranked 50th in the state. The 1996-2006 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Shelby had a total personal income (TPI) of \$376,175*. This TPI ranked 61st in the state and accounted for 0.4 percent of the state total. In 1996 the TPI of Shelby was \$287,038* and ranked 60th in the state. The 2006 TPI reflected an increase of 1.2 percent from 2005. The 2005-2006 state change was 4.2 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 2.7 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Shelby. In 2006 net earnings accounted for 63.0 percent of TPI (compared with 59.6 in 1996); dividends, interest, and rent were 16.2 percent (compared with 23.6 in 1996); and personal current transfer receipts were 20.7 percent (compared with 16.8 in 1996). From 2005 to 2006 net earnings increased 0.8 percent; dividends, interest, and rent decreased 6.4 percent; and personal current transfer receipts increased 9.7 percent. From 1996 to 2006 net earnings increased on average 3.3 percent each year; dividends, interest, and rent decreased on average 1.0 percent; and personal current transfer receipts increased on average 4.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Shelby remained unchanged. The 2005-2006 state change was 3.6 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$167,956* to the 2006 estimate was 2.7 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
