



BEARFACTS 1996 – 2006

Todd , Kentucky [21219]

Todd is one of 120 counties in Kentucky. It is not part of a Metropolitan Area. Its 2006 population of 11,932 ranked 89th in the state.

PER CAPITA PERSONAL INCOME

In 2006 Todd had a per capita personal income (PCPI) of \$22,228. This PCPI ranked 75th in the state and was 75 percent of the state average, \$29,542, and 60 percent of the national average, \$36,794. The 2006 PCPI reflected a decrease of 3.4 percent from 2005. The 2005-2006 state change was 5.2 percent and the national change was 6.1 percent. In 1996 the PCPI of Todd was \$18,628 and ranked 33rd in the state. The 1996-2006 average annual growth rate of PCPI was 1.8 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Todd had a total personal income (TPI) of \$265,224*. This TPI ranked 87th in the state and accounted for 0.2 percent of the state total. In 1996 the TPI of Todd was \$216,456* and ranked 74th in the state. The 2006 TPI reflected a decrease of 2.8 percent from 2005. The 2005-2006 state change was 6.1 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 2.1 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Todd. In 2006 net earnings accounted for 62.5 percent of TPI (compared with 67.8 in 1996); dividends, interest, and rent were 12.3 percent (compared with 14.3 in 1996); and personal current transfer receipts were 25.3 percent (compared with 18.0 in 1996). From 2005 to 2006 net earnings decreased 9.2 percent; dividends, interest, and rent increased 12.9 percent; and personal current transfer receipts increased 8.9 percent. From 1996 to 2006 net earnings increased on average 1.2 percent each year; dividends, interest, and rent increased on average 0.5 percent; and personal current transfer receipts increased on average 5.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Todd decreased from \$132,896* in 2005 to \$108,660* in 2006, a decrease of 18.2 percent. The 2005-2006 state change was 4.6 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$125,008* to the 2006 estimate was - 1.4 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.5 percent.
