



BEARFACTS 1996 – 2006

Lewis and Clark , Montana [30049]

Lewis and Clark is one of 56 counties in Montana. It is part of the Helena, MT Micropolitan SA. Its 2006 population of 58,898 ranked 6th in the state.

PER CAPITA PERSONAL INCOME

In 2006 Lewis and Clark had a per capita personal income (PCPI) of \$34,185. This PCPI ranked 3rd in the state and was 110 percent of the state average, \$31,061, and 93 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 8.9 percent from 2005. The 2005-2006 state change was 5.5 percent and the national change was 6.1 percent. In 1996 the PCPI of Lewis and Clark was \$21,306 and ranked 3rd in the state. The 1996-2006 average annual growth rate of PCPI was 4.8 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Lewis and Clark had a total personal income (TPI) of \$2,013,416*. This TPI ranked 6th in the state and accounted for 6.9 percent of the state total. In 1996 the TPI of Lewis and Clark was \$1,151,539* and ranked 6th in the state. The 2006 TPI reflected an increase of 10.4 percent from 2005. The 2005-2006 state change was 6.7 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 5.7 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Lewis and Clark. In 2006 net earnings accounted for 65.7 percent of TPI (compared with 64.6 in 1996); dividends, interest, and rent were 20.1 percent (compared with 21.3 in 1996); and personal current transfer receipts were 14.3 percent (compared with 14.1 in 1996). From 2005 to 2006 net earnings increased 8.8 percent; dividends, interest, and rent increased 16.8 percent; and personal current transfer receipts increased 9.3 percent. From 1996 to 2006 net earnings increased on average 5.9 percent each year; dividends, interest, and rent increased on average 5.1 percent; and personal current transfer receipts increased on average 5.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Lewis and Clark increased from \$1,507,715* in 2005 to \$1,650,283* in 2006, an increase of 9.5 percent. The 2005-2006 state change was 5.4 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$934,458* to the 2006 estimate was 5.9 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.5 percent.
