



BEARFACTS 1996 – 2006

Greene , Virginia [51079]

Greene is one of 105 counties in Virginia. It is part of the [Charlottesville, VA \(MSA\)](#). Its 2006 population of 17,551 ranked 71st in the state.

PER CAPITA PERSONAL INCOME

In 2006 Greene had a per capita personal income (PCPI) of \$31,220. This PCPI ranked 45th in the state and was 78 percent of the state average, \$40,234, and 85 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 8.1 percent from 2005. The 2005-2006 state change was 5.9 percent and the national change was 6.1 percent. In 1996 the PCPI of Greene was \$18,719 and ranked 63rd in the state. The 1996-2006 average annual growth rate of PCPI was 5.2 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Greene had a total personal income (TPI) of \$547,950*. This TPI ranked 68th in the state and accounted for 0.2 percent of the state total. In 1996 the TPI of Greene was \$245,187* and ranked 81st in the state. The 2006 TPI reflected an increase of 10.5 percent from 2005. The 2005-2006 state change was 7.1 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 8.4 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Greene. In 2006 net earnings accounted for 74.2 percent of TPI (compared with 76.1 in 1996); dividends, interest, and rent were 13.4 percent (compared with 11.7 in 1996); and personal current transfer receipts were 12.4 percent (compared with 12.2 in 1996). From 2005 to 2006 net earnings increased 8.2 percent; dividends, interest, and rent increased 24.6 percent; and personal current transfer receipts increased 10.7 percent. From 1996 to 2006 net earnings increased on average 8.1 percent each year; dividends, interest, and rent increased on average 9.9 percent; and personal current transfer receipts increased on average 8.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Greene increased from \$137,170* in 2005 to \$142,482* in 2006, an increase of 3.9 percent. The 2005-2006 state change was 5.3 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$78,946* to the 2006 estimate was 6.1 percent. The average annual growth rate for the state was 6.6 percent and for the nation was 5.5 percent.
