



BEARFACTS 1996 – 2006

Frederick + Winchester , Virginia [51921]

Frederick + Winchester is one of 105 counties in Virginia. It is part of the [Winchester, VA-WV \(MSA\)](#). Its 2006 population of 96,436 ranked 25th in the state.

PER CAPITA PERSONAL INCOME

In 2006 Frederick + Winchester had a per capita personal income (PCPI) of \$33,850. This PCPI ranked 30th in the state and was 84 percent of the state average, \$40,234, and 92 percent of the national average, \$36,794. The 2006 PCPI reflected an increase of 6.3 percent from 2005. The 2005-2006 state change was 5.9 percent and the national change was 6.1 percent. In 1996 the PCPI of Frederick + Winchester was \$21,950 and ranked 28th in the state. The 1996-2006 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Frederick + Winchester had a total personal income (TPI) of \$3,264,384*. This TPI ranked 21st in the state and accounted for 1.1 percent of the state total. In 1996 the TPI of Frederick + Winchester was \$1,701,106* and ranked 25th in the state. The 2006 TPI reflected an increase of 9.0 percent from 2005. The 2005-2006 state change was 7.1 percent and the national change was 7.1 percent. The 1996-2006 average annual growth rate of TPI was 6.7 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Frederick + Winchester. In 2006 net earnings accounted for 70.9 percent of TPI (compared with 69.3 in 1996); dividends, interest, and rent were 16.8 percent (compared with 19.4 in 1996); and personal current transfer receipts were 12.3 percent (compared with 11.3 in 1996). From 2005 to 2006 net earnings increased 6.5 percent; dividends, interest, and rent increased 20.2 percent; and personal current transfer receipts increased 10.1 percent. From 1996 to 2006 net earnings increased on average 7.0 percent each year; dividends, interest, and rent increased on average 5.2 percent; and personal current transfer receipts increased on average 7.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Frederick + Winchester increased from \$2,463,536* in 2005 to \$2,625,286* in 2006, an increase of 6.6 percent. The 2005-2006 state change was 5.3 percent and the national change was 5.8 percent. The average annual growth rate from the 1996 estimate of \$1,385,276* to the 2006 estimate was 6.6 percent. The average annual growth rate for the state was 6.6 percent and for the nation was 5.5 percent.
