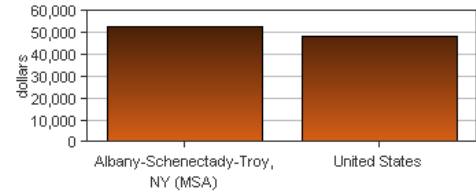

Albany-Schenectady-Troy, NY (MSA) is one of Metropolitan Statistical Areas (MSAs) in United States. Its 2015 population of 881,830 ranked 62nd in the United States.

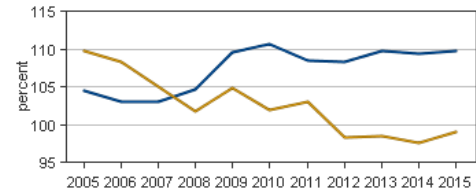
Per Capita Personal Income

In 2015, Albany-Schenectady-Troy, NY (MSA) had a per capita personal income (PCPI) of \$52,899. This PCPI ranked 36th in the United States and was 111 percent of the state average, \$47,633, and 110 percent of the national average, \$48,112. The 2015 PCPI reflected an increase of 4.1 percent from 2014. The 2014-2015 state change was 5.2 percent and the national change was 3.7 percent. In 2005, the PCPI of Albany-Schenectady-Troy, NY (MSA) was \$37,553 and ranked 56th in the United States. The 2005-2015 compound annual growth rate of PCPI was 3.5 percent. The compound annual growth rate for the state was 1.9 percent and for the nation was 3.0 percent.

Personal Income

In 2015, Albany-Schenectady-Troy, NY (MSA) had a personal income of \$46,647,540*. This personal income ranked 58th in the United States and accounted for 103.5 percent of the state total. In 2005, the personal income of Albany-Schenectady-Troy, NY (MSA) was \$32,093,354* and ranked 57th in the United States.

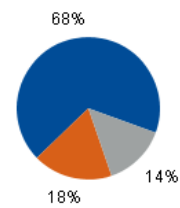
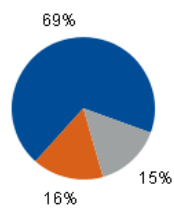

Percent Contribution to Personal Income

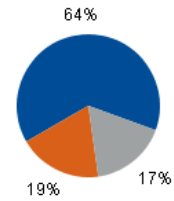
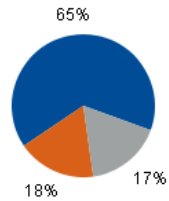
