



# Des Moines-West Des Moines, IA (MSA)

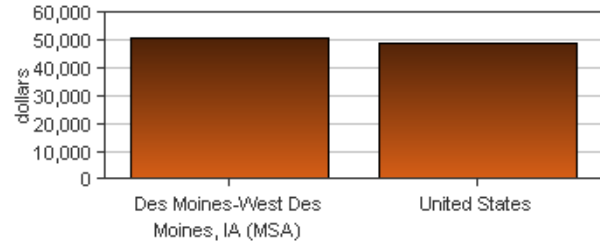

Des Moines-West Des Moines, IA (MSA) is one of Metropolitan Statistical Areas (MSAs) in United States. . Its 2016 population of 634,725 ranked 89th in the United States.

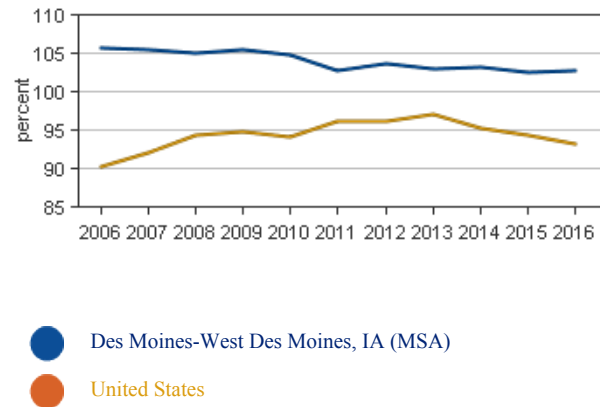
## Per Capita Personal Income

In 2016, Des Moines-West Des Moines, IA (MSA) had a per capita personal income (PCPI) of \$50,677. This PCPI ranked 61st in the United States and was 110 percent of the state average, \$46,000, and 103 percent of the national average, \$49,246. The 2016 PCPI reflected an increase of 1.8 percent from 2015. The 2015-2016 state change was 0.6 percent and the national change was 1.6 percent. In 2006, the PCPI of Des Moines-West Des Moines, IA (MSA) was \$40,411 and ranked 53rd in the United States. The 2006-2016 compound annual growth rate of PCPI was 2.3 percent. The compound annual growth rate for the state was 2.9 percent and for the nation was 2.6 percent.

## Personal Income

In 2016, Des Moines-West Des Moines, IA (MSA) had a personal income of \$32,166,099\*. This personal income ranked 75th in the United States and accounted for 22.3 percent of the state total. In 2006, the personal income of Des Moines-West Des Moines, IA (MSA) was \$21,528,479\* and ranked 80th in the United States.

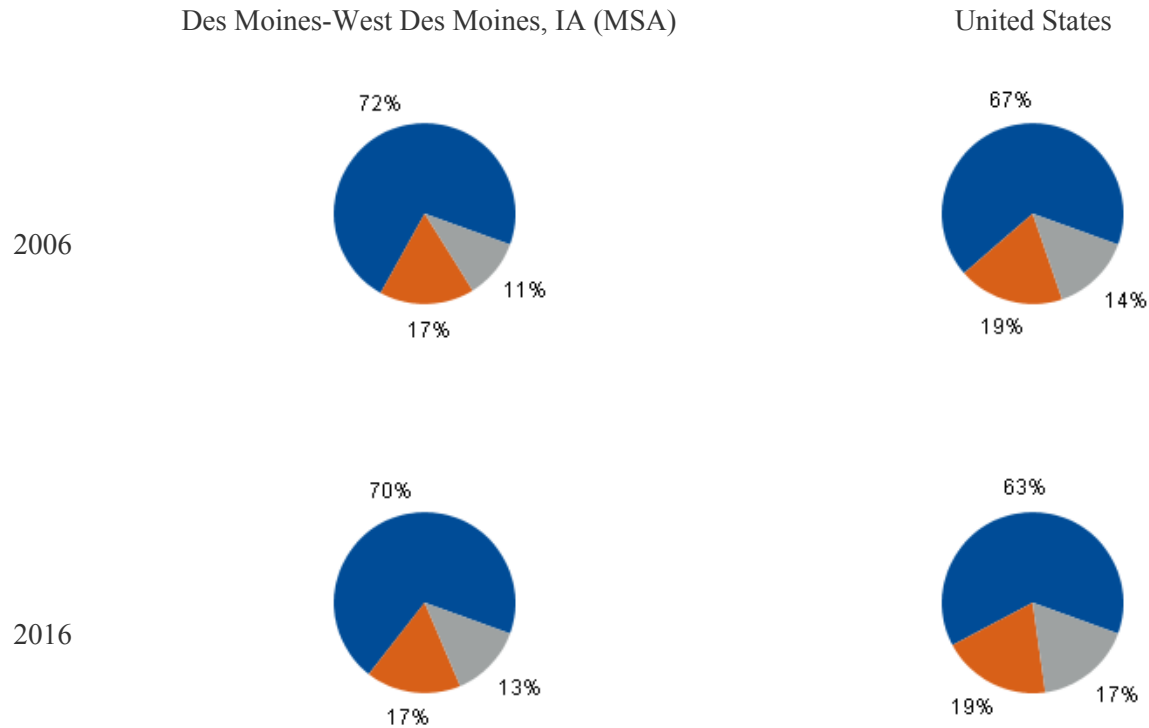
