



State BEARFACTS 1989 – 1999

Vermont

The population of Vermont in 1999 was 604,683. Its rank was 49th in the nation.

PER CAPITA PERSONAL INCOME

In 1999 Vermont had a per capita personal income (PCPI) of \$25,881. This PCPI ranked 29th in the United States and was 93 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 5.1 percent from 1998. The 1998-1999 national change was 3.9 percent. In 1989 the PCPI of Vermont was \$17,365 and ranked 22nd in the United States. The 1989-1999 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Vermont had a total personal income (TPI) of \$15,649,530*. This TPI ranked 48th in the United States. In 1989 the TPI of Vermont was \$9,684,854* and ranked 48th in the United States. The 1999 TPI reflected an increase of 5.8 percent from 1998. The 1998-1999 national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 4.9 percent. The average annual growth rate for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and total personal current transfer receipts received by the residents of Vermont. In 1999 net earnings accounted for 65.2 percent of TPI (compared with 66.7 in 1989); dividends, interest, and rent were 20.4 percent (compared with 21.7 in 1989); and personal current transfer receipts were 14.4 percent (compared with 11.6 in 1989). From 1998 to 1999 net earnings increased 7.2 percent; dividends, interest, and rent increased 1.1 percent; and personal current transfer receipts increased 6.6 percent. From 1989 to 1999 net earnings increased on average 4.7 percent each year; dividends, interest, and rent increased on average 4.3 percent; and personal current transfer receipts increased on average 7.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Vermont increased from \$10,593,782* in 1998 to \$11,333,031* in 1999, an increase of 7.0 percent. The 1998-1999 national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$7,225,558* to the 1999 estimate was 4.6 percent. The average annual growth rate for the nation was 5.6 percent.
