


## **Real Disposable Income Rises in December**

<b>Personal income</b> increased 0.3 percent in December, the same increase as in November. Wages and salaries, the largest component of personal income, increased 0.2 percent in December after increasing 0.5 percent in November.		Oct.	Nov.	Dec.
